Governor Deukmejian appointed Dick Ernest as director of the California Department of Forestry and Fire Protection (CDF) on Wednesday, March 15, 1989.

There was cheering and clapping in the halls of Sacramento Headquarters when the news broke, and a smiling Dick Ernest in the middle of it all.

He had only to wait until that afternoon when Terry Egan, undersecretary Resources Agency swore him in as the director. Of course Dick now has to wait for official confirmation by the Senate.

Dick's had a long CDF career beginning in 1951 when he joined on as a seasonal firefighter at the Corona Forest Fire Station in Riverside County. In 1953 he entered the U.S. Marine Corps and served in the Korean Conflict.

He left the Marine Corps as a sergeant in 1956 and returned to CDF as a forest fire truck driver. Since that time he has served as an aerial patrolman, fire prevention officer, ranger-in-charge of Monterey County, and assistant chief of Fire Protection.

In 1975 Dick received the Silver Smokey Award for his outstanding work in fire prevention.

He was appointed Region I Chief in 1981 and assumed the responsibility for operations in the state's coast region. In March, 1987 he was appointed to the position of chief deputy director for CDF by Director Partain. Working closely with the director, he administered all operations within the department.

When Director Partain retired at the end of 1988 Dick was appointed acting director.

Dick was born in Scotts Bluff, Nebraska in 1934 and lived in Billings, Montana before moving to Riverside County in 1940.

Married since 1955, he and his wife, Blanche, live in the Rocklin area of Placer County. They have four children and three grandchildren.

#### Is RAMP for you?

The Resources Agency Management Program (RAMP) is nearing the end of it's first two-year cycle since being restructured. Gordon Van Vleck, secretary, Resources Agency, says that the enthusiasm and support generated by the program has more than met his expectations.

RAMP is essentially a management training program which allows participants to rotate through three eightmonth tours with different departments or commissions within the Resources Agency. It is geared at creating effective managers. Participants work in the areas of budget and fiscal planning; legislation; public information and communication; personnel/affirmative action; and resource management.

Kathleen Cronin, a participant in the current program (she spent eight months with CDF's Public Affairs and Legislation section), said that the program was "absolutely worthwhile". It provides you with experience in three different departments, something you don't usually get in state service.

She added that being a "management trainee", allows participants to observe and question management more extensively than a regular employee.

Often times participants are hired

on permanently by one of the departments they go through. Those who are not hired go back to their original positions with some fabulous experience for their resumes and promotional exams.

If you are at a level equivalent to a staff services analyst, (range B) or higher, and have already spent two-years working with one of the resources agency departments or commissions, you may be eligible to participate in the RAMP Program.

The 1989-1990 program will begin on July 3, 1989. If you are interested you must act now as interviews will be scheduled in May. Contact Roy Grimes, CDF RAMP Coordinator, at (916) 323-8965.



#### Fireman Of The Year



Warren Powers, a heavy fire equipment operator (HFEO) in the Sonoma Ranger Unit, was recently honored as the 1988 Fireman Of The Year for the Sebastopol City Fire Department.

Warren began his fire service career in 1952 as a seasonal firefighter with the California Division of Forestry, (CDF). After three summers and a two-year hitch in the U.S. Army, Warren was hired as a forest fire truck driver in 1958. In 1968 he became a reserve police officer in Sebastopol and continued that association until his appointment in 1971 as a police officer.

Warren was the first and only person to ever be a police officer and volunteer firefighter at the same time. He remained with the Sebastopol Police and Fire Department until his return to CDF on a full-time basis in 1980. He returned to the Sebastopol Fire Department in 1982 and has been a member ever since.

Warren and his wife, Ruth, have seven children and four grandchildren. Two of his sons are members of local Fire Departments; one with the Santa Rosa City Fire Department, and one with Twin Hills Fire Protection District and CDF. To complete the family's association with the Fire Service, Warren's daughter works for Santa Rosa Fire Equipment.

#### Chamberlain Creek - changing through the years

Chamberlain Creek Conservation Camp is located in the middle of the 50,000 acre Jackson Demonstration State Forest. east of Fort Bragg in Mendocino County.

The camp was constructed in 1959 and originally designed to house 60 male inmates. In 1971 Governor Reagan closed Chamberlain Creek as a California Department of Corrections (CDC) Camp and reopened it shortly after as a federal camp housing illegal aliens. The federal program ended approximately two years later when the camp was re-established as a CDC camp in late 1973.

In 1981, due to the increasing state inmate population, Chamberlain Creek was expanded to an 80 man camp. It expanded again in 1983 to the present 100 man camp. A great deal of time, money and effort has gone into this facility over the last few years to keep up with demands as the operation grows in size.

Since the initial expansion began we have completely replaced both water and sewer systems, constructed a new six stall bus barn/mechanics shop, added a 40' X 22' expansion onto the existing kitchen for food storage, installed firewalls and gang showers in the dormitory and completed numerous other internal modifications. It should be noted that

most of these accomplishments were performed using existing staff skills and inmate labor.

Chamberlain Creek operates five fulltime fire crews. Crews #1, 2, 3, and 4 perform various grade projects such as maintenance of state parks, stream clearance for Fish and Game to improve fish habitat, Cal Translitter pick-up, pine cone picking for CDF, and numerous other projects for both local and state agencies, along with maintenance of fuel breaks within the Mendocino Ranger Unit.

Crew #5 is our in-camp production shop crew which operates a cabinet shop "SECOND TO NONE". craftmanship developed by our cabinet shop keeps us continuously booked with proj-Major renovation of the Davis Facility Lab, virtually the entire remodeling of the emergency command center at Region I Headquarters in Santa Rosa, and the one of a kind Madrone Reception Center at the Mendocino Ranger Unit Headquarters, have been Chamberlain Creek projects to name a few.

The camp was placed under the administration of the Mendocino Ranger Unit in 1987, improving already excellent relations with the ranger unit personnel. In the spring and summer Chamberlain Creek crews can be found scattered throughout the ranger unit, working under supervision of the local battalion chiefs. The crews accomplish many station maintenance and improvement projects in and around the station grounds plus joint training sessions on hoselays and other wildland firefighting evolutions.

The last couple of years have seen an almost total turnover of personnel for both agencies at the camp, and the facility is undergoing a major renovation and reorganization. With our enthusiastic, progressive staff we will see Chamberlain Creek Camp become the most sought after camp in the system for personnel from both agencies.

Chamberlain Creek is jointly administered by State Forest Ranger II Noel Lockwood and CDC Lieutenant Larry

Olesen, with a staff of ten fire crew captains, one heavy fire equipment operator, seven correctional officers and two correctional sergeants.

If you are in the area stop by to see what we feel is probably the best camp in the system!



The evening entertainment/training session was provided by VIP Kendal Bortisser and his companion Pumper. Kendal is a fireman with the San Miguel Consolidated Fire Protection District and volunteers on his days off teaching children how to be fire safe. He starts by introducing himself, then explains exactly what a firefighter does, i.e. fighting fire, search and rescue, medical emergencies, etc. Next he demonstrates how to put on his protective gear and how each piece works to keep him safe.

Then Kendal dons breathing apparatus, and spends some time explaining how it works, what it looks and sounds like. Kendal demonstrates the noises it makes, and try's to talk, explaining to the audience how he looks frightening and sounds like Darth Vader; but tells the children not to be frightened because the firefighter is there to help them. (In a classroom setting he selects one child to try the turnout gear on).

Kendal then discusses 911, explaining what information the dispatcher will need, and how the number should never be played or experimented with. He also informs the children that 20 cents is not required at a pay phone when using

911.

Smoke detectors and Exit Drill In The Home (E.D.I.T.H.) are the next topics of discussion. Kendal stresses the importance of how fire safe preplanning can save your life and your familiy's in an emergency situation. He also goes over Smokey Bear's five rules of match safety - very important for young impressionable children.

Lastly, the catalyst for the whole program, Kendal introduces Pumper, his specially trained Dalmatian dog. He has Pumper demonstrate the Stop, Drop, and Roll techniques for his audience. (In the classroom a few children are also selected to practice Stop, Drop, and Roll.) This is always the high point of his program - using Pumper really makes his fire safety messages sink in.

All of the volunteers present thoroughly enjoyed Kendals presentation, as it served as a timely reminder to us all. The evening was a great success and people have already started looking forward to next years dinner.

# Your Health and Safety

#### EAP: This isn't how it was supposed to be.

Maintaining an intimate relationship can be hard work. Nearly one out of two marriages in this country end in divorce. Even when couples stay together, growing differences in values or expectations, lack of communication, economic pressures, alcohol or drug abuse, power conflicts, or martial infidelity may cause conflict and tension.

Some couples deal with these problems by denying or ignoring them, attempting to compensate in some way to fill the void in the relationship, escalating conflict, or making unreasonable demands on their partner. Other couples may choose to see a professional counselor.

When a person has grown dissatisfied with the quality of the relationshipif it begins to cause pain on a continuing basis, or if communication problems put a distance between partners—then either partner or both partners may want to

seek professional assistance in evaluating, clarifying, and resolving their situation. There are three basic types of relationship counseling: marital, relationship enhancement, and divorce counseling.

Marital counseling focuses on discussing and clarifying needs and feelings of the partners. Counselors have various means to assist partners in identifying the reasons for disagreements or communication breakdown. The counselor and the couple can work together to problem-solve and clear away the resentments that are causing distress.

Relationship enhancement counseling involves improving communication, building greater respect and sensitivity, clarifying needs, and learning to understand the impact of and accept differences between partners. The counselor will use positive reinforcement to assist couples to build or strengthen their relationships.

Divorce counseling helps couples cope with feelings of failure and fears about their future relationships. While divorce almost always causes considerable pain, guilt, and anger, dealing with a divorce is also the beginning of a new growth process. Divorce counselors assist individuals in gaining new insights in order to become more mature and resourceful.
